FOBRA – Transport Report September 2025

WECA Mayor

Due to the WECA election at the beginning of May there has been a period of reduced activity on transport matters. To date there have been no detailed announcements setting out any substantial changes in transport policy under the new Mayor.

B&NES Interactive Transport Map

B&NES has published a "Transport Action Map" which is described as collecting information about "current and future transport projects set to be delivered, developed and studied over the next three years". Park & Ride Extended Hours Trial until August

Please do make all your members aware of the extended-hours trials currently taking place at all three Park & Ride sites. Under the Trial the last bus leaving the City Centre to all P&Rs will be at 11.30pm. FoBRA has long supported extending P&R hours to enable use by those who wish to extend their visit into the evening or to come into Bath for dinner or events. Consultations/Liveable Neighbourhoods

Feedback is awaited on a number of completed consultations.

There are a number of Traffic Regulation Orders currently open for consultation. These include proposals for apparently relatively minor changes to parking arrangements in various parts of the city, new cycle hangar locations, and a reduction of the 40mph speed limit on the A4 Saltford (these should all have been advertised in notices in the relevant locations). Somer Valley Links

Following a recent meeting with a representative of Wellsway RA in which they shared concerns they had following the most recent consultation on this "Strategic Transport Corridor" scheme, we were pleased to be able to put their representative in touch with the appropriate Officer within B&NES to discuss their safety concerns.

B&NES Cabinet

There has been a re-arrangement of roles in the B&NES Cabinet relating to Highways. Whilst the precise distribution of responsibilities is not yet completely clear, these new transport-

related roles are Cabinet Member for Sustainable Transport Strategy (Joel Hirst) and Cabinet Member for Sustainable Transport (Lucy Hodge), with Sarah Warren retaining overall responsibility for sustainability policy as Cabinet Member for Sustainable Bath & North East Somerset.

Update: As part of the local plan options document, transport planning and traffic movement strategy will be part of the process and the consultation. We will ensure that when Sophie Broadfield Executive Director of Sustainable Communities holds the FoBRA meeting to discuss the impact of 29,000 new homes built in the region that this issue will be discussed.
